

MINUTES
SPECIAL COUNCIL MEETING
CITY OF NICEVILLE, FLORIDA
SEPTEMBER 22, 2011

The Niceville City Council met in special session at 6:00 PM, September 22, 2011 in the Council Chambers, 208 N Partin Drive. All council members, and the Mayor were present. Also present were City Manager Lannie Corbin; City Clerk Dan Doucet; Director of Public Works Bruce Price; and a member of the press. Mayor Wise called the meeting to order at 6:00 PM.

PUBLIC HEARINGS

Ordinance 11-09-04 - An ordinance of the City of Niceville, Florida levying the AD Valorem Property Tax millage rate for municipal purposes on all taxable property within the City for the Fiscal year beginning October 1, 2011 and ending September 30, 2012 stating the percentage by which the millage to be levied exceeds the rolled-back rate; and providing for an effective date. (Third Reading)

Mr Doucet read ordinance 11-09-04 in it's entirety and stated the proposed millage rate of 3.65 is the recommended rate for FY-12. He stated the percentage by which this millage rate to be levied exceeds the rolled-back rate of 3.7177 (computed pursuant to Florida law) is - 1.82%. Mr Doucet advised that the revenues received will be used to defray budgeted General Fund Expense. Councilman Thomas moved approval on third reading. Councilman Henkel seconded. No one spoke for or against. Mayor Wise asked for a roll call vote: Council Vote: Henkel-yes; Schaetzle-yes; Thomas-yes; Rominger-yes; Smith-yes. Motion passed.

Ordinance 11-09-05 - An ordinance adopting the final budget for the City of Niceville for the fiscal year commencing October 1, 2011; an ordinance adopting and approving the appropriations set forth in said budget for the fiscal year commencing October 1, 2011; and providing for an effective date. (Third Reading)

Mr Doucet read ordinance 11-09-05 by title. Councilman Thomas moved approval on third reading. Councilman Rominger seconded. No one spoke for or against. Council Vote: Henkel-yes; Schaetzle-yes; Thomas-yes; Rominger-yes; Smith-yes. Motion passed.

Ordinance 11-09-06 - An Ordinance of the City of Niceville, Florida repealing or amending firearms control regulations as required by Florida House Bill 45; providing for authority; providing for findings of facts; providing for the repeal of code of ordinances Chapter 13 Offenses, Section 13-2 discharge of firearms prohibited, and Section 13-3 discharge or possession of certain other weapons prohibited; providing for incorporation into the code of ordinances; providing for conflicting provisions; providing for severability; and providing for

an effective date. (Second Reading).

Mr Doucet read Ordinance 11-09-06 by title. Councilman Henkel moved approval on second reading. Councilman Smith seconded. No one spoke for or against. Council Vote: Henkel-yes; Schaetzle-yes; Thomas-yes; Rominger-yes; Smith-yes.

Mr Doucet stated the next council meeting is scheduled for September 30, at 6:00 PM.

The meeting adjourned at 6:15 PM.
