MINUTES SPECIAL COUNCIL MEETING CITY OF NICEVILLE, FLORIDA SEPTEMBER 20, 2016

The Niceville City Council met in special session at 6:00 PM, September 20, 2016 in the Council Chambers, 208 N Partin Drive. All council members, and the Mayor was present. Also present were City Manager Lannie Corbin; City Clerk Dan Doucet; Attorney Dixie Powell; Chief Popwell, Police Department; Chief Mayville, Fire Department; and Chad Morris, Technology Department. Mayor Wise called the meeting to order at 6:00 PM.

PUBLIC HEARING

Ordinance 16-09-03 - An ordinance of the City of Niceville, Florida levying the AD Valorem Property Tax millage rate for municipal purposes on all taxable property within the City for the Fiscal year beginning October 1, 2016 and ending September 30, 2017 stating the percentage by which the millage to be levied exceeds the rolled-back rate; and providing for an effective date. (Third Reading)

Mr Doucet read Ordinance 16-09-03 in its entirety. Councilwoman Boudreaux moved approval on third reading. Councilman Nodjomian seconded. Mr Doucet stated the percentage by which the millage rate of **3.70 mills** exceeded the rolled back rate of **3.6099 Mills** (computed pursuant to Florida law) is **2.50%.** Mr Doucet advised that the revenues received will be used to defray budgeted General Fund Expense. No one spoke for or against. Council Vote: Henkel-yes; Schaetzle-yes; Boudreaux-yes; Nodjomian-yes; Rominger-yes. Motion Passed

Ordinance 16-09-04- An ordinance adopting the final budget for the City of Niceville for the fiscal year commencing October 1, 2016 an ordinance adopting and approving the appropriations set forth in said budget for the fiscal year commencing October 1, 2016 and providing for an effective date. (Third Reading)
