Ordinance 18-01-01 – an ordinance of the City of Niceville, Florida amending Ordinance No. 558 which vacated and abandoned a right-of-way portion of old Niceville Avenue in the Nathey Estate adjustment subdivision, Niceville, Florida; providing for the express reservation by the City of a perpetual easement across said property of a width of 30 feet for the maintenance, repair and usage of existing and future utility lines; providing for removal of the restriction in the reservation of the said 30 foot easement area be kept free of paving or other improvements thereupon; providing for allowing paving over the said 30 existing easement subject to the reservation of easement; providing for repeal of conflicting provisions; providing for severability; and providing for an effective date.
