

CITY ELECTION – UPDATE

THE CITY OF NICEVILLE CHARTER WAS AMENDED BY ORDINANCE 22-08-02 DATED 16 AUGUST 2022. ONE OF THE MAJOR CHANGES WAS TO TRANSFER THE ELECTION PROCESS TO THE OKALOOSA COUNTY SUPERVISOR OF ELECTIONS OFFICE. THEY WILL OVERSEE AND MANAGE ALL ASPECTS OF THE ELECTION PROCESS WHICH INCLUDES THE CANDIDATE QUALIFYING PROCESS.

QUALIFYING WOULD NORMALLY START JANUARY 2, 2023, HOWEVER THAT IS THE DAY BEING OBSERVED FOR NEW YEAR'S DAY, SO THE SUPERVISOR OF ELECTIONS OFFICES WILL BE CLOSED. JANUARY 3, 2023 WILL BE THE FIRST DAY THE SUPERVISOR OF ELECTIONS OFFICE WILL BE OPEN TO QUALIFY. JANUARY 3-5 YOU WILL BE ABLE TO QUALIFY FROM 8 AM TO 5 PM AND ON JANUARY 6TH FROM 8 AM TO NOON.
